REQUIREMENTS FOR PAGEANT PARTICIPATION:

YOU MUST HAVE A SPONSOR TO PARTICIPATE IN THE CONTEST. YOU ARE RESPONSIBLE FOR ASKING FOR SPONSORSHIP, BUT THE CHAMBER WILL BE AVAILABLE TO ASSIST YOU, SHOULD YOU ENCOUNTER PROBLEMS FINDING A SPONSOR. SPONSORSHIP COSTS \$75.00 AND IS PAYABLE TO THE CHAMBER OF COMMERCE. THESE FUNDS GO TOWARDS THE CONTEST AND THE \$500 SCHOLARSHIP RECEIVED BY THE GIRL SELECTED.

THIS YEAR THE MISS KIMBLE COUNTY PAGEANT WILL BE HELD IN CONJUNCTION WITH THE TWIST OFF RODEO ON MAY 7TH AND 8TH, WITH THE CROWNING CEREMONY TO TAKE PLACE AT THE SATURDAY EVENING PERFORMANCE ON MAY 8TH.

WE ARE ASKING EACH CONTESTANT TO BE RESPONSIBLE FOR DECORATING SOME KIND OF A "FLOAT" FOR HER TO RIDE IN/ON PORTRAYING OUR THEME IN HER OWN SPECIAL STYLE. THERE IS NO RIGHT OR WRONG WAY, AND IS NO RULE AS TO WHAT HER "FLOAT" MUST BE. THIS IS PERSONAL EXPRESSION OF EACH CONTESTANT.

PARADE THEME THIS YEAR:

"READY OR NOT, HERE I COME!"

THE PARADE IS ON SATURDAY MORNING, MAY 8TH AT 10:00 am ON MAIN STREET IN JUNCTION, TX.

CONTESTANTS RIDE IN OR ON SOME SORT OF NICELY DECORATED "FLOAT", OF THEIR CHOOSING, WHETHER IT IS A PICKUP, HORSE, CAR, 4-WHEELER, ETC. EACH CONTESTANT'S NAME, CLASSIFICATION, AND SPONSOR SHOULD BE DISPLAYED ON THE FLOAT. INDIVIDUAL PARADE FLOATS WILL BE CONSIDERED AS PART OF THE EVALUATION PROCESS BY JUDGES IN THE SELECTION OF MISS KIMBLE.***

PAGEANT PARTICIPANTS WILL PROCEED TO THE COURTHOUSE STEPS IMMEDIATELY FOLLOWING THE MORNING PARADE, AND BE ASKED ONE "INTERVIEW QUESTION" AS PART OF THE JUDGING PROCEDURE.***

***** JUDGING IS AS FOLLOWS:**

1/3 FLOAT PARTICIPATION

1/3 QUESTION/ANSWER AT COURTHOUSE

**1/3 JUDGES OVERALL IMPRESSION AS TO ENTRANTS COMPOSURE,
LEVEL OF PARTICIPATION, AND ATTITUDE.**

ALSO, THE PAGEANT CONTESTANTS ARE RESPONSIBLE FOR SUBMITTING A 200 WORD ESSAY, MAXIMUM 400 WORDS, DUE MAY 5, 2009, BY 5 PM AT THE CHAMBER OFFICE ON THE TOPIC, "WHEN I WISH UPON A STAR, I WISH...". (THERE WILL BE A CASH PRIZE AWARDED FOR THE BEST ESSAY AND THESE ESSAYS ARE NOT JUDGED UNTIL THE SELECTION FOR THE MISS KIMBLE AND HER COURT IS COMPLETED.)

REQUIRED ATTIRE:

FRIDAY EVENING, MAY 7TH – RODEO ATTIRE FOR CONTESTANT AND ESCORT

SATURDAY MORNING PARADE, MAY 8TH – DRESS TO YOUR BEST ADVANTAGE IN ACCORDANCE WITH THE THEME OF YOUR FLOAT

SATURDAY EVENING, MAY 8TH – FORMALS FOR CONTESTANTS AND COAT AND TIE FOR ESCORTS.

CO-CHAIRMEN OF MISS KIMBLE CONTEST ARE YET TO BE DETERMINED. CONNIE WILL CONTACT THE CONTESTANTS FOR SETTING A SPECIFIC TIME FOR REHEARSAL ON THURSDAY EVENING BEFORE THE EVENT WEEKEND.
